Instructions for authors:

- Paper abstract should be in English no more than 500 words and contain: Introduction to the study and aim, it's objectives and/or hypotheses, methods used and/or approach taken, results and/or arguments summarized, conclusion and main outcomes of the study.
- Paper should have no more than 2 authors. One author is authorized submit no more than one paper;
- Paper should be prepared in **Microsoft Word** (2007, 2010, 2013, 2016) and saved in **.doc** or **.rtf** format;
- Paper should contain no more than 10 pages of A4 format;
- Paper consists of title, author(s)' data (name, institution, faculty, study level, program, course), supervisor's data (name, institution, department, academic degree and position), abstract, keywords, content and reference;

- Font name - Sylfeen, size 12, Paragraph line spacing 1.15, Margins: left-right -1.5cm, top-bottom – 2.5cm;
- Presentation should take no more than 10 minutes and 5 minutes for discussions.

Author(s) of accepted papers will be awarded the certificate of participation.

Author(s) of the best papers will be awarded with the relevant certificate and papers will be published in electronic journal on University web page.

Conference summary will be held on 19 may, 2018 in the resort “Sairme”.
