 - ➤ **abstracts in Ukrainian or English** (the file name should correspond to the name and initials of the participant, as well as include the sector number (for example: Goncharuk Y.M._3), in the subject line of the e-mail indicate: "Name and initials of the author");
 - ➤ for students of higher education institutions, an additional review (photo/scan signed by the supervisor or send a review from the supervisor's corporate email if the abstract was prepared solely by the student).

Acceptance Notification of the abstracts will be sent to the organizing committee within 5 calendar days from their receipt by e-mail to the Organizing committee.

Participants who have not received the Notification are kindly requested to check their spam and duplicate the email if necessary. Abstracts that do not meet the requirements and those submitted after the deadline will not be considered.

An electronic collection of abstracts with an ISBN code will be published based on the conference results and placed in the repository of KNEU named after Vadym Hetman (http://ir.kneu.edu.ua/) as an electronic publication, link to which will be sent to the authors' email address specified in the application form approximately by June 15, 2025. In addition, the electronic collection of abstracts will be located on the website of the Department of Banking and Insurance.

REQUIREMENTS FOR ABSTRACT FORMATION

- 1. Abstracts are prepared in MS Word: A4 format, font Times New Roman; font size 14; line spacing 1.0; dimensions: paragraph indent 1.0 cm; all fields 2.0 cm.
- 2. *The file name* must match the surname and initials of the author (or first co-author) and also include the number of thematic sectors of the conference

The file is saved in one of the formats .doc, .docx, .rtf (for example: Goncharuk Y._3.docx).

- 3. *Number of co-authors*: no more than 2 co-authors; no more than two abstracts are accepted from one author (co-author).
- 4. Working languages of the conference: Ukrainian, English.
- 5. **Recommended volume of abstracts** up to 3 pages of text (including figures, tables and references).
- 6. *Page numbering* is not affixed, hyphens in the text are not allowed.
- 7. Figures and tables are made in Microsoft Word and Microsoft Excel using black and white colors and placed in the text while maintaining the possibility of their editing. Tables and figures scanned from other publications are not allowed to be placed in the text. All tables and figures must be titled using the Times New Roman font, 12pt, bold and presented in portrait orientation. Consecutive numbering of figures and tables in Arabic numerals (Fig. 1; Table 1), as well as references to them in the text are requed.
- 8. *Formulas are placed in the center*, numbered in parentheses on the right. The Microsoft Equation Editor is used to type formulas.
- 9. *References to sources of information* are made in the text in square brackets. The first digit is the source number in the list of references, the second is the page number. The source number and page number are separated by a comma, the source numbers are separated by a semicolon, for example: [1, 95-96], [2; 5; 7]. Numbering is in the order of references to the source.
- 10. The list of **references** is compiled by publications that are usually no older than 5 years and is given at the end of the abstract, in the order of mention in the text (font size -10, regular, spacing -1.0, width alignment). The list of references is drawn up in accordance with the requirements used for formation of scientific works. For electronic references, a valid link is required.
- 11. Materials are published in the author's edition. Responsibility for the scientific level of abstracts, the validity of conclusions, the reliability of results and compliance with academic integrity lies with the authors.

The Organizing Committee of the Conference has the right not to accept materials that are prepared without complying with the specified requirements!

The sequence of materials in abstracts:

On the right - the surname and initials of the author (co-author) in bold.

Below - the scientific degree, academic title, position of the author (co-author); for students: the name of the educational program, course.

Below - the full name of the educational institution (organization).

Below, one line apart - the name of the abstract in large bold letters (center alignment).

Below, one line apart - the text of the abstract (width alignment).

Below, one line apart - List of sources used.
