Are you interested in the widely discussed questions and problems?

- Does international division of labour generate economic benefits for all partners involved?
- Why is international trade taking place within industries (intra-industrial trade)?
 Complementarity in trade relations is largely over, no more trade of agricultural products and raw materials against investment and high-tech consumer goods.
- 3. Why do we see more and more fragmentation of production on the international level?

 Audi produces gear boxes in Hungary, electronic equipment in the Czech Republic and fixing the car together in Germany.
- 4. What are the motivations for foreign direct investment?
- 5. Is President Trump right by saying: "we have to protect our US steel industry and protect the jobs of American steel workers by introducing higher tariffs and also reduce the deficit in the trade balance"? According to him trade wars are easy to win. What about these arguments?
- 6. Are the Chinese RHB as well as the Euro undervalued and thus giving advantages to European and Chinese exporters?
- 7. Will the monetary system collapse?

This introductory course designed for bachelor students of economics and management of 3rd and 4th year will give answers to all of these questions. The course is taught by a team of professors of three European universities who have cooperated closely together in the past by creating dual-degree programmes in international economics, business and development. The course covers thirty hours of teaching and will give students who have successfully passed a final examination 3 ECTS points. The programme is divided into six days of intensive teaching (5 hours per day). Two days are devoted to international trade theory, two days to international trade policy and two days to international monetary economics,
